Biyografi

I received my M.A. and Ph.D. degrees in Economics from Vanderbilt University and am currently working as a Professor of Economics in the Faculty of Business at Dokuz Eylül University in Turkey. I have also held academic appointments in the Department of Economics at Vanderbilt University, Adnan Menderes University, Izmir University of Economics (part-time), and the University of California-Santa Cruz (Research Fellow), where I taught undergraduate and graduate courses in econometrics, statistics, financial economics, managerial economics, quantitative methods, game theory, and mathematical economics. My research generally focuses on the efficiency, competition, risk, and stability of financial institutions. I have also published some papers on volatility and forecasting of financial variables. Recently, I have started research on energy economics and have published several papers in this area. My published papers have appeared in *International Business Review*, *Empirical Economics*, *Economic Modeling*, *Applied Economics*, *Emerging Market Review*, *Journal of International Financial Markets, Institutions & Money*, *Economic Systems*, *The North American Journal of Economics and Finance*, *Journal of Applied Economics*, *Empirica*, *Physica A*, *Energy Economics*, *Energy*, *Environmental Science and Pollution Research*, *Bulletin of Economic Research*, *Emerging Markets Trade and Finance*, *International Review of Applied Economics*, and *International Journal of the Economics of Business*.
